This matter came before the Court on the Joint Motion to Modify the Preliminary Approval Order of the proposed class action settlement (the "Settlement") of the case entitled *In re: Convergent Outsourcing, Inc. Telephone Consumer Protection Act Litigation*, United States District Court for the District of Connecticut, Case No. 3:13-md-02478-AWT, MDL No. 2478 (the "Action"). Based on the Court's review of the Parties' Joint Motion to Modify the Preliminary Approval Order, the Court finds good cause to grant the Parties' motion. Accordingly, IT IS HEREBY ORDERED:

1. <u>Final Approval Hearing</u>. At 2:00 p.m. on **November 10, 2016**, in South Courtroom of the Abraham Ribicoff Federal Building, 450 Main Street, Hartford, CT, or at such other date and time later set by court order, the Court will hold a Final Approval Hearing on the fairness, adequacy and reasonableness of the Agreement and to determine whether (a) final approval of the Settlement embodied by the Agreement should be granted, and (b) Class Counsel's application for attorneys' fees and expenses, and service award to Plaintiff, should be granted, and in what amount. No later than **August 24, 2016**, Plaintiff must file papers in support of Class Counsel's application for attorneys' fees and expenses and the service award to the Plaintiff. No later than **October 26, 2016**, which is fifteen (15) days prior to the Final Approval Hearing, papers in support of final approval of the Settlement and response to any written objections must be filed.

2. <u>Schedule of Future Events</u>. Accordingly, the following are the modified deadlines by which certain events must occur:
