City's New U.S. Courts to be Dedicated June 14

Hartford's two new federal courtrooms will be dedicated in simple but impressive ceremonies June 14 at the just-completed U.S. Courthouse and Federal Building at 450 Main

The dedication, which will be open to the public, will be marked by a rare massing of the federal judiciary in the state plus Connecticut's chief justice and chief justicedesignate.

U.S. Circuit Judge Charles E. Clark, former chief judge of the 2nd Circuit Court of Appeals will head a list of seven federal judges expected to attend. ...

Judge Clark, former Yale Law School dean, will be the main speaker and will be introduced by Chief U.S. District Judge Robert P. Anderson, who will direct the ceremonies starting at 10:30 a.m.

U.S. Circuit Judge J. Joseph Smith, who sat on the federal trial bench in Hartford for nearly 20 years before he was

named to the 2nd Circuit Court of Appeals, is expected to attend. Judge Smith will have chambers in the new building. Other federal judges expected

are: U.S. Circuit Judge Thomas Swan and U.S. District Judges Clarie will sit in the two new William H. Timbers, M. Joseph Blumenfeld and T. Emmet Clarie.

Judge Blumenfeld and Judge modern. gold - backdropped courtrooms which occupy the second floor of the wings at the north and south end of the structure.

The second floor of the building also houses a smaller courtroom for use by the Chief

Judge Anderson when he hears cases at Hartford. There will also be a Bankruptcy Court for U.S. Referee in Bankruptcy Saul Sideman and a hearing room for U.S. Commissioner George C. Hastings.

Chief Justice Raymond E. Baldwin and Chief Justice-Designate John Hamilton King head a list of state court judges who will be invited to attend the dedication.

Prof. Julian N. Hart, Noah Porter Professor in Philosophy and Theology and chief of the department of religious studies at the Yale Divinity School, will give the invocation.

Atty. Leo Gaffney, president of the state bar association and Atty, William K. Cole, president of the Hartford County Bar, will he invited to represent their respective organizations.

Atty, Max M. Savitt is chairman of the county bar committce arranging the dedication ceremonies. Others on the committee are Cole, Asst. U.S. Atty. James D. O'Connor, Atty Loon RisCassi and Atty. Frederick J. Rundbaken.
